

Data privacy:

While you access this website, our server will store all access-related information (date, time, page viewed). These data will be used exclusively for statistical purposes. They will only be analysed in anonymized form.

Where this internet offering prompts users to enter their personal or business data (e-mail addresses, names, mail addresses), users shall provide this information explicitly on a voluntary basis.

When you send us an e-mail or voluntarily provide us with your personal data within the context of public events (trade fairs, conferences) or of customer visits, your e-mail address and other personal data shall only be used for individual correspondence with you.

Your information will be kept confidential in accordance with all legal provisions in force.

Your personal data shall not be transmitted to third parties external to the processing of the contract without your explicit consent or a legal basis. Upon completion of the contract, your data shall be blocked for any further use. These data shall be deleted upon expiry of all relevant provisions relating to commercial and fiscal law unless you explicitly agree to the further use of your data.

Your personal data required for the formation of the contract, for its contents or the modification of the contractual relationship (inventory data) will be used exclusively for processing this contract. For example, your name and address will be transmitted to a forwarder for the purpose of delivering the goods.

As far as technically feasible or reasonable, the use of the offered services shall be permitted without entering such data or upon entering anonymized data or a pseudonym. The third-party use of contact data, such as postal addresses, telephone and fax numbers or of e-mail addresses published in the imprint or in other comparable media for the purpose of mailing information not explicitly requested shall be prohibited. Legal steps against senders of so-called spam mails in contravention to this prohibition are explicitly reserved.

USE OF COOKIES

GOOGLE ANALYTICS

We use Google Analytics, a web analysis service of Google Inc. ("Google"). Google uses cookies. The information that the cookies produce about the use of our online services are as a rule transmitted to a Google server in the USA and stored there. Google will use this information on our behalf in order to analyze the use of our internet offering in order to compile reports about activities within this internet offering and to provide us with further services in relation to the use of this online offering and the use of the internet. In this context, the processed data can be used to compile pseudonymous user profiles.

We use Google Analytics only with an activated IP anonymization. This means that the user's IP address will be truncated by Google within member states of the European Union or other EEA Treaty members. The IP address transmitted by your user browser shall not be combined with other Google data.

Retargeting functions:

Use of interest-based retargeting

This website uses so-called retargeting tags. Retargeting tags are JavaScript elements placed in the source code of a website.
